




# REPUBLIC ACT NO. 11234

**“An Act Establishing the Energy Virtual One-Stop Shop for the Purpose of Streamlining the Permitting Process of Power Generation, Transmission, and Distribution Projects”**

**(Energy Virtual One-Stop Shop Act)**



# Energy Virtual One-Stop (EVOSS) Act



# Declaration of Policy

- a) Ensure the quality, reliability, and security of energy at reasonable cost by undertaking measures to guarantee that supply meets demand in a timely manner;
- b) Recognize the indispensable role of the private sector in power generation, transmission, and distribution by attracting new power generation, transmission, or distribution projects through an improved ease of doing business index, and reducing high transaction costs associated with copious requisites for proponents;
- c) Ensure transparency and accountability in the process of approving power generation, transmission, or distribution projects; and



# Declaration of Policy

- e) Deliver efficient and effective service to public by:
  - 1. Ensuring timely completion of power generation, transmission, or distribution projects by:
    - i. eliminating duplication, redundancy, and overlapping mandates in documentary submissions and processes
    - ii. supplying an online platform for government agencies to coordinate and share information; and
  - 2. Providing a paperless and electronic application and processing system which serves as a single gateway
    - i. through which proponents can access all information necessary in the application for a new generation, transmission, or distribution project
    - ii. submit all requirements related to the application, and monitor the approval of such application



# Scope\*

- Subject to Sections 9(j) and 11(i) of the Act, all new power generation, transmission, and distribution projects throughout the country
  - Government agencies and other relevant entities involved in the permitting process
- 
- *Consistent with Section 9(j), Sec. Alfonso G. Cusi, Vice-Chairperson, EVOSS Steering Committee recommended to the EVOSS Steering Committee the expansion of the use of the platform to include other energy licensing processes, if any.*
  - *Consistent with Section 11(i) , the EVOSS Steering Committee approved the recommendation of the Vice-Chairperson to expand the use of the platform to other energy licensing processes;*



# EVOSS Functions



Recognize the legal effect, validity, and enforceability of **electronic documents** submitted



Establish a system of **high availability, business continuity and cyber security**




Utilize a **technology platform and an operations management software platform** to build defined processes and forms within a strict timeframe using published standards



# EVOSS Characteristics



Operate as a **one hundred percent (100%) virtual storage** and rules driven system built as an **integrated shared service**



Provides a secure and accessible **paperless system** which proponents may:

1. Obtain list of all electronic documentary requirements
2. Prepare, submit, process, and receive actions on all submitted electronic documentary requirements
3. Monitor and inquire on the status of ongoing applications
4. Calculate, pay, and settle all appropriate fees electronically
5. Submit complaints concerning Inaction on submitted electronic documents



Utilizes **online payment system** for all fees imposed for applications



Provide a **secure and accessible system** for all Government agencies and entities involved in the permitting process to **interoperate** with respect to:



# Prohibited Acts and Penalties

Administrative Offenses	Penalties	
	Government Official/Employee	Private Entity
a) Willful refusal to participate in the EVOSS.	<b>1<sup>st</sup> offense</b> - 30 days suspension without pay <b>2<sup>nd</sup> offense</b> - 3 months suspension without pay <b>3<sup>rd</sup> offense</b> - Dismissal and perpetual disqualification from public service.	In cases of violation by the system operator and market operator of (a), (b), and (c), the ERC shall impose a fine of One hundred thousand pesos (P100,000.00) for every day of delay.
b) Willful acts which delay the operationalization of the EVOSS.		
c) Failure to comply with the mandated timeframes as provided in this Act, or as imposed by the EVOSS Steering Committee.	<b>1<sup>st</sup> offense</b> - 30 days suspension without pay and mandatory attendance in Values Orientation Program; <b>2<sup>nd</sup> offense</b> - 3 months suspension without pay; <b>3<sup>rd</sup> offense</b> - Dismissal and perpetual disqualification from public service, and forfeiture of retirement benefits.	
d) Tampering with EVOSS or any part or component thereof.	Dismissal and perpetual disqualification from public service.	
e) Divulging information or releasing any aspect of a document submitted by a project proponent to anyone other than an authorized person or agency.
